

REGULATIONS FOR PARTICIPATION IN “THE MALL RACE”

Design Management S.r.l. unipersonale, with registered office in Via San Paolo 7, Milan 20121, tax code and VAT no. 05063610488 (“DeMa”), hereby presents the regulations for the automotive event called “The Mall Race” which will take place from 17 to 19 April 2026, of which DeMa is the sole owner, and which is organized by Class&Classic SAGL (“**Organizer**”), with registered office in Via Stazione 18, Bellinzona (Switzerland), CHE-443.971.581 (“**Event**”). The Event will have a touristic nature, featuring a route between Leccio (FI) and Sanremo (IM).

REGULATIONS OF THE EVENT

Art. 1

The Event will take place from 17 to 19 April 2026 and will consist of an automotive route starting in Tuscany and ending in Liguria, including several stops detailed in these regulations and in the Event program. Participation is subject to acceptance by the Organizer and is reserved for vehicles of any type or make, built between 1930 and 2025.

The Event will have a maximum of 30 (thirty) vehicles.

Vehicles with dealer plates and/or not registered for road use will not be admitted.

Art. 2

For participation in the Event, the Organizer will select vehicles which, relative to their era of design and construction, display distinctive elements in terms of style, design, innovation of lines and shapes, personality, and stylistic and technological innovations.

The following applies:

- the touristic route between Leccio (FI) and Sanremo (IM) will be defined by the Organizer, with a stop at the shopping centers The Mall Firenze, located in Leccio Reggello (FI), Via Europa 8, and The Mall Sanremo, located in Sanremo, Via Armea 43;
- Participants must follow the route in compliance with the Italian Highway Code (the “**Participants**” and, individually, the “**Participant**”).

Art. 3

Vehicles admitted to the Event must be in perfect working condition, and vehicles with license plates must comply with the Highway Code and have valid insurance for the entire duration of the Event.

If the vehicles fail to meet these requirements, including due to issues arising after the start of the Event and at any time during it, they will be immediately excluded without any indemnity and/or refund of the fees paid.

A valid driver’s license recognized under the laws of the issuing country is required for participation.

The Event is non-competitive; therefore, no rankings and/or classifications will be provided, and each Participant will receive a participation prize.

Art. 4

DeMa and the Organizer reserve the right to confirm or cancel the Event up to 28 February 2026, and the Organizer will send appropriate notice to the Participants. Should the Event be cancelled, the Organizer will – at the Participant’s discretion – refund the participation fee already paid in full, or provide a voucher for another event organized by the Organizer, within 30 (thirty) days, without

Participants being entitled to any other indemnity and/or refund for any reason.

Art. 5

The categories of vehicles admitted exclusively upon selection by the Organizer, according to the criteria indicated in Article 2, are as follows:

- Pre- and Post-war Sedans, Coupés, and Sports Cars up to 1965
- Sports cars and barchettas up to 1965
- Racing GTs up to 1985
- Road-going supercars and special cars of all eras up to 1985
- Modern supercars and GTs produced up to 2025

Art. 6

Applications must be submitted by each Participant by completing the registration form available on the website <https://themall.it/it/themallrace>, including all required information and attaching all requested documentation.

The Event has limited availability, as stated in Article 1; therefore, the evaluation and acceptance of each registration request will be subject to availability. The date of submission of the application and the subsequent confirmation received from the Organizer will determine priority.

Within 10 days of receiving the application, the Organizer will send the applicant a confirmation e-mail containing the Organizer's bank details for payment of the participation fee. Payment must be made within 5 days of receiving the acceptance confirmation.

Registration will be considered completed only once the participation fee has been paid by each Participant.

The management of participation fees and payments is the exclusive responsibility of the Organizer, and DeMa will not be involved in any way. The Organizer shall indemnify and hold DeMa harmless from any claim, request, action, and/or dispute by Participants relating to the management of said payments.

Art. 7

The participation fee is €1,150.00 (one thousand one hundred fifty/00) per vehicle with 2 (two) persons, and €980.00 (nine hundred eighty/00) for a vehicle with 1 (one) person.

The following services are included in the participation fee:

- Registration of the vehicle and driver/co-driver (if applicable);
- Accommodation in a 4-star hotel from Friday, 17 April to Sunday, 19 April 2026;
- Dinners on 17 and 18 April 2026;
- Lunches on 17, 18, and 19 April 2026;
- Driver's welcome bag;
- Activities included in the program indicated on the Event registration page on the website <https://themall.it/it/themallrace>.

All services not included in this Article 7 shall be at the expense of each Participant.

The participation fee shall be paid to the Organizer as indicated in Article 6.

Art. 8

The Organizer and DeMa decline all liability for any damage to vehicles, Participants, accompanying persons, third parties, property, and/or objects, without exception, and to the owners of vehicles who attend directly or indirectly before, during, or after the Event. Under no circumstances shall the Organizer or DeMa be held legally liable for the above-mentioned aspects, nor called upon for compensation for damages to persons or property, even partial.

The Organizer may exclude from the Event, effective immediately, any crews exhibiting negligence, dangerous driving, blatant violation of traffic laws and regulations in effect in the territories crossed, or behavior endangering third parties, without any refund of the fees paid.

By accepting registration, the Participant undertakes to fully comply with the above conditions, all applicable laws and regulations, and the Highway Code.

The Participant shall conduct themselves according to principles of fairness, good faith, and respect toward other Participants, the Organizer, and third parties. The Participant undertakes to:

- comply with these regulations and all applicable laws and regulations;
- refrain from actions and/or behaviors that may disrupt the proper conduct of the Event and, in general, any behavior contrary to public decency, public order, or morality, or which may harm the image and reputation of the Organizer and DeMa;
- avoid behavior that may be offensive and/or harmful to the dignity of others.

Failure to comply with the above may result—at the discretion of the Organizer—in the immediate exclusion of the Participant from the Event, without any right to indemnity and/or refund, without prejudice to any civil or criminal liabilities.

Art. 9

By accepting these regulations, Participants declare that they participate in the Event at their own risk, assuming all responsibilities related to any act, occurrence, or incident during the Event that involves damage to persons and/or property. Participants further declare that the Organizer and DeMa shall not be held legally liable under any circumstances for the above-mentioned aspects, nor called upon for compensation for damages to persons or property, even partial.

Art.10

Participants wishing to withdraw from the Event must send an email to themallrace@victorious.ch expressly stating their intention to cancel their registration.

The Organizer agrees to refund Participants the amount paid according to the following schedule:

- Withdrawal by 31 January 2026: Refund of 50% of the participation fee;
- Withdrawal by 28 February 2026: Refund of 20% of the participation fee;
- Withdrawal from 1 March 2026: No refund of the participation fee.

In the event of cancellation of the Event or failure to hold it due to force majeure not attributable to the Organizer or DeMa—such as, by way of example but not limited to, floods, health emergencies, fires, wars, or prohibitions issued by competent authorities—the Organizer shall be exempt from all liability, and no indemnity shall be due to Participants. The participation fees paid will be managed exclusively by the Organizer, who undertakes to offer each Participant, at their discretion, either:

(i) a full refund of the fee paid; or

(ii) a voucher of equal value, usable for a future event organized by the Organizer.

In all cases, the Organizer shall be solely responsible for managing said fees and shall indemnify and hold DeMa harmless from any claim, request, or action Participants may raise regarding the cancellation of the Event or the handling of participation fees.
